When a voltage is applied between the transparent electrode and a counter electrode provided on another substrate side, a refractive index of the liquid crystal composition varies by a dielectric anisotropy of the liquid crystal composition, so that a desired display can be realized by controlling light transmittance in the liquid crystal layer. In this liquid crystal display device, in order to uniformly form display of high quality, it is important to perform a uniform display by satisfying a relation of $\Delta n \times d$ (Δn : refractive index anisotropy of the liquid crystal, d : cell gap) which is a magnitude (magnitude of m (applied voltage/applied electric field)) of a drive voltage ($\Delta n \times d$), where Δn is a magnitude of refractive index anisotropy of the liquid crystal composition (Δn =refractive index along a direction of liquid crystal director (director) V : vertical direction and refractive index along a direction of liquid crystal director (director) H : horizontal direction, and in an initial state of the liquid crystal display device, liquid crystal is aligned so that the direction of liquid crystal director (director) V lies in the vertical direction and the direction of liquid crystal director (director) H lies in the horizontal direction), for each liquid crystal cell.
