[8] Victim's psychiatric records. Appellant Reves contends that the court erred in excluding evidence that 20 years earlier the victim, Mr. Staga, was diagnosed by a psychiatrist and that the psychiatrist's diagnostic impression was Alcoholism with sexual psychopathy. This patient is not an outstanding patient for psychiatric treatment. This diagnosis was contained in a psychiatric report which appellant contends was admissible as a hospital business record under Evidence Code section 1271. The trial court held that it was not, and precluded appellant from introducing the report into evidence and from examining Dr. Fantl as to the use he made of the report when he examined Reyes. In addition to the analyses discussed above, we have carried out a number of analyses that help to confirm the results of the COVID-19 HGI study. First, we carried out a broad look at the data in the context of known COVID-19-related variants as indexed by the GWAS Catalog (study code GCAT072000) and the COVID-19 GWAS Catalog (study code GCAT010500). While we did not observe an association of these variants with COVID-19 hospitalization, we did observe associations in the SARS-CoV-2 studies. Associations were observed in the Neale lab (n = 3,727) and FinnGen Freeze 4 cohort (n = 20,345), but not in the Neale lab (n = 4,531) and eQTL data (n = 14,476). The latter result is not too surprising since the SARS-CoV-2 infection data were obtained from samples collected a median of 3.4 months later than the first visit to the FinnGen Freeze 4 cohort. Since the second visit to the FinnGen Freeze 4 cohort was within the study period, the population of SARS-CoV-2-positive individuals by that time will be an enriched sub-population of the total population. These results suggest that the variants identified in COVID-19 HGI () are likely to be true positive findings, confirming the result of the GWAS Catalog COVID-19 HGI () and the GWAS Catalog SARS-CoV-2 () analyses.Second, since the COVID-19 HGI () and GWAS Catalog SARS-CoV-2 () studies were each designed to identify genetic predictors of SARS-CoV-2 infection, we compared the effect sizes of those variants in the COVID-19 HGI () data to the effect sizes of the same variants in the SARS-CoV-2 GWAS Catalog (). For a full subset of 34 variants identified in both GWAS Catalog analyses (Supplementary Figure 6), we observed a strong correlation between the effect sizes for COVID-19 hospitalization and SARS-CoV-2, with correlation coefficient (r) of 0.93 (P = 3.5

In any event, the evidence offered by the prosecution simply fails to exclude with reasonable certainty the hypothesis that someone else committed the crime. (Pen. Code, 1111.) Circumstantial evidence cannot substitute for direct evidence, and the suspicion of guilt which may be engendered by the proven facts is not inconsistent with a reasonable hypothesis of innocence. (People v. Newland (1940) 15 Cal. 2d 678, 681 [104 P.2d 778]; People v. Hillery (1965) 62 Cal. 2d 692, 702 [44 Cal. Rptr.

30, 401 P.2d 382].) It is not enough for the prosecution to prove the crime was committed by someone, for the prosecution

still must prove that person's identity. (People v. Hillery, supra; People v. Leach (1959) 175 Cal. App. 2d 526, 530 [346 P.2d 786].)

In order to convict it was incumbent upon the prosecution to prove beyond a reasonable doubt that Reyes committed the

homicide. (People v. Hillery, supra; People v. Moore (1956) 47 Cal.2d 737, 746-747 [306 P.2d 1];

People v. Trent (1941) 46 Cal. App. 2d 505, 512 [116 P.2d 143].)
